The I ABIERTO NACIONAL DE PARA NATACIÓN - COLOMBIA 2017 will be governed by the rules of the I World Para Swimming Classification Rules and Regulations 2014 – 2017 del IPC (International Paralympic Committee)

The I ABIERTO NACIONAL DE PARA NATACIÓN - COLOMBIA 2017 will be held with the IPC Competition System, S1 – S14, SB1 – SB14, SM1 SM14, according to the criteria established by the IPC, including the categories S15, SB15 and SM15 for hearing impairment in which the results will only be updated at the national level.

For national athletes, the el I Abierto Nacional de Paranatación will be considered as he National Championship for this sport.

5. CLASSIFICATION

The functional classifications will be done according to the procedure and politics of the World Para Swimming Classification Rules and Regulations.

5.4 HEARING CLASSIFICATION

The Colombian Sports Federation of Deaf (Fecoldes) will give the respective participation guarantee, before the closure of inscriptions. All athletes who require qualification must arrive one hour before the assigned time.

Notes:

- All new athletes must send their requests for classification in the correct format before August 2 of 2017 (After this date no requests will be received)
- The application for functional classification, is made through the registration platform, selecting the "Yes" option to the question "Requires National Classification?" Please note that the closing date for this application is August 2, 2017, which is why athletes must have completed the registration form on the platform and select the classification option.
- Athletes who request classification are reminded that they must be present before the qualifying panel one (1) hour in advance with the updated medical history to the year 2017, for the related practice and their respective supports.

9. ELEGIBLE ATHLETES

The athletes that are eligible to compete in the el I ABIERTO NACIONAL DE PARA NATACIÓN - COLOMBIA 2017 must fulfill the following requirements.

- Athletes must be at least 12 years of age before December 31 in the year of the competition. (* Exceptional cases, please contact the Organizing Committee).
- Athletes with international classification with Confirmed (C) or Revision (R) status.
- Athletes with New status (N) must send the classification request according to dates established by the organizing committee for this case.
- Have coverage in health (eps or sisben) and in the case of foreign assistance card.
- The participation by their respective federation is guaranteed

10. CATEGORIES

In the I ABIERTO NACIONAL DE PARA NATACIÓN - COLOMBIA 2017 will have open categories and junior:

Note: Junior athletes will de rewards in an additional category apart if they place their self's in the first three places of the senior category.

- Each athlete may enroll in a maximum of four (4) events per day, three (3) individual and one (1) per team.

11. AWARDS

The official award ceremonies in the OPEN NATIONAL OF SWIMMING - COLOMBIA 2017 will be held as follows:

Three (3) or more athletes per trial, modality and / or category, when all three regions exist (NPCs act as a region for the purposes of allowing prizes) will be rewarded as

Gold Medal	First Place
Silver Medal	Second Place
Bronze Medal	Third Place

If there are less than three political sections/ number of athletes, the award ceremony will be held in the following way:

Gold Medal	Compliance of 90% of the Record America to July 31, 2017
Silver Medal	Compliance with 85% of the Record of the Americas on July 31, 2017
Bronze Medal	Compliance with 80% of the Record of the Americas on July 31, 2017

We will apply -1 law in case that there are less than four athletes from three sections or delegations

12. ANTI- DOPING CONTROL

Doping control will be conducted in accordance with the IPC Anti-Doping Code and the IPC and WADA (World Anti-Doping Agency) Anti-Doping Control Agreement. <https://www.paralympic.org/swimming/rules-and-regulations/anti-doping>

It is important that all athletes who participate in the event and who require the use of a substance from the list of prohibitions for medical reasons fill out the TUE (the format is in the following link:

and must be sent 25 days before the start of the competition (August 4, 2017) to the anti-doping e-mail of agarzon@coldeportes.gov.co with copy to antidopaje@cpccolombia.org

13. OFICIAL RESULTS

The results will be found on the official website of the Colombian Paralympic Committee once the competition is over. The results will be reviewed and the ranking list will be updated accordingly.

14. PARTICIPATION REGISTRY

Only the athletes who endorse the respective National Federation can participate, for which the regional password must be requested before the respective federation to register on the page of the Colombian Paralympic Committee. In the case of invitations to international organizations will be the Paralympic Committee of each country that authorizes their participation before the CPC.

Note: According to the national politics, athletes will not be allowed to use the National Team uniforms during this event. The only uniforms allowed will be the ones authorized by every region. This will only apply for the Colombian athletes.

The withdrawal or non-participation of a member of the delegation, after the end of this period, any person registered if he does not present a medical support in which the reason for his absence is justified, shall cancel the registration value of the event and may not Participate in any other event organized by the CPC without having canceled this value.

17. LEGALIZATION OF INSCRIPTIONS

The legalization of the Inscriptions will be made at the time of receiving the rosettes and this will be accepted only in the consignment formats generated by the Bancolombia bank and in the account number established. Cash payments (national delegations) will not be accepted, nor payments after the event.

"If an accreditation is used by another person, it will be annulled and the athlete who owns it will be expelled from the championship"

Note: region and / or country that registers personnel (athletes, staff, doctor, among others) and do not participate in the same event must assume the final costs of registration
